Early Childhood Education

Here are the eligibility requirements for the Peer Model Program

- You must be a resident of the Auburn-Washburn School District, except for employee children and grandchildren.
- The age of your child must be 3 or 4 years of age and not of the age to attend kindergarten.
- A 3-year-old peer must be 3 by August 31, 2018.
- Your child must not have any current identified needs or currently be on an Individual Education Plan (IEP).
- Your child must be fluent in speaking and understanding English.
- Your child **MUST** be toilet trained.
- Transportation will be included to and from school.
- There is a six-week trial period in the preschool for peer model placements. If during this period concerns are noted in the area of social interactions, behavior, or social communication, a conference will be scheduled to discuss termination of placement by the Early Childhood Special Education team.

Please Note:

- ✓ The deadline for submitting an application is February 7, 2018.
- ✓ Because of the limited number of classroom slots available, not all children with applications will be screened. You will be notified by phone or email by February 16 if your child is asked to attend the screening.
- ✓ The screening will be held on March 2 from 9 AM-11 AM.
- ✓ Three-year-olds will be screened at Farley Elementary. Four-year-olds will be screened at Wanamaker Elementary.
- ✓ Parents will be contacted by letter on or before March 9 as to whether their child was accepted into the Peer Model program.

A limited number of peer model spots are available. Parents should proceed with making other arrangements for the 2018-19 school year as a backup plan in the event their child is not selected.

I have read the letter clarifying eligibility procedures for peer models and understand that there is a six-week trial period for continued participation.

Tuition is computed for a ten (10) month school year and paid in monthly installments starting August 1st, with the last payment made on May 1st.

Tuition Payment Policy for the Peer Model Program

- The monthly tuition is \$175.00 for five days per week.
- Payment is due by the first day of services each month.
- If payment is made by check, please make the check to USD 437. Payments should be handed directly to building secretary or be mailed to the school office. Please mark payment "preschool".
- Payments made by mail must arrive on due date.
- Payments may be made online.
- Receipts for tuition will be emailed monthly upon request.
- A \$20.00 penalty will be assessed on the 15th of the month for unpaid installments.
- If the installment is not paid by the end of the month, your child may be dropped.
- Amounts past due over 90 days may be turned over to a collection agency.
- All unpaid tuition must be paid in full before re-enrollment can be handled by the school.
